1. It will be mandatory to comply with all the provisions of Maharashtra Self Help schools (Establishment and Regulation) ACT 2012.
2. Permission is being given to this school by the rule of reference no 2. Accordingly if the organization does not has all the requirements as per the provisions of Maharashtra Self – Aided Schools (Establishments and Regulations) Act 2012, it will be mandatory for them to start the school within eighteen months from the date of GR of reference number permission automatically will be cancelled.
3. No change can be made in the future recognition of the organization will be cancelled.

4. Receipt of donation (Permanent Deposit) must be in the name of the organization for the next three years, from the date of submission of school recognition proposal. Concerning the renewal after the deadline, the institution/School management should be held as collateral with the Education Officer (Primary) to establish new schools under the Maharashtra Self – Aided Schools (Establishment and Regulation) Act 2012 from the Academic year 2021-22 and to upgrade existing schools, being offered.
5. Physical facilities will be required in the schools which have been approved for standardization. Income of the Primary Schools, it will be mandatory to meet all the standards mentioned in RTE ACT 2009.
6. If the land/land proposed by the school is not found as per one acre land/land as per rules, the recognition will be cancelled.
7. Receipt of donation (Permanent Deposit) must be in the name of the organization for the next three years, from the date of submission of school recognition proposal. Concerning the renewal after the deadline, the institution/School management should be held as collateral with the Education Officer (Primary) to establish new schools under the Maharashtra Self – Aided Schools (Establishment and Regulation) Act 2012 from the Academic year 2021-22 and to upgrade existing schools, being offered.
